Iconic investor crowned the world's richest man in March as Berkshire Hathaway shares ran up 25% between July 2007 and February 2008. Berkshire stock has fallen 15% since, erasing \$12 billion from Oracle of Omaha's fortune in 6 months and forcing him to cede the title back to friend and bridge partner Bill Gates. Son of Nebraska politician delivered newspapers as a boy. Filed first tax return at age 13, claiming \$35 deduction for bicycle. Studied under value investing guru Benjamin Graham at Columbia. Took over textile firm Berkshire Hathaway 1965. Today holding company invested in insurance (Geico, General Re), jewelry (Borsheim's), utilities (MidAmerican Energy), food (Dairy Queen, See's Candies). Also has noncontrolling stakes in Anheuser-Busch, Coca-Cola, Wells Fargo. Berkshire Hathaway sales in 2007: \$118 billion. Issued a challenge to members of The Forbes 400 last October; said he would donate \$1 million to charity if the collective group would admit they pay less taxes, as a percentage of income, than their secretaries. Irrevocably earmarked the majority of his Berkshire shares for charity in 2006, mostly to the Bill & Melinda Gates Foundation. Has given \$6 billion worth of shares so far.

John Haggerty, who had previously been trusted as Michael Bloomberg's aide, was recently accused of embezzling \$1.1 million from the mayor's 2009 campaign. Haggerty tried to get the indictment dismissed, but Manhattan Supreme Court Judge Ronald Zweibel denied the defendant's bid as he noted that the evidence of guilt [was] overwhelming.

According to the New York Daily News, Haggerty was responsible for administrating the Election Day operation for Mayor Bloomberg with the \$1.1 million funneled through the state Independence Party. Instead, Haggerty allegedly used at least \$75,000 to purchase a home in Queens and only spent a small portion of the mayor's funds on poll operations.

"[The] defendant is not Robin Hood, stealing from the rich and giving to the poor," wrote Judge Zweibel in a ruling 15 pages long. "He concocted this elaborate scheme because he needed the money to buy out his brother's share of the family home."

Haggerty was caught in the middle of the embezzlement scheme when newspapers began to investigate Mayor Bloomberg's donation to the Independence Party, said Zweibel. "As to the evidence of guilt, whether admissible at trial or not, is overwhelming," he wrote. "The people presented testimony by eyewitnesses, documents and admissions by defendant ... and his failed attempt to cover up his theft."

It remains unclear whether Zweibel's ruling might encourage John Haggerty to try making plea negotiations at this time, but the judge has ordered him to face trial. Haggerty is expected again in court in June for another hearing.

Ben S. Bernanke began a second term as Chairman of the Board of Governors of the Federal Reserve System on February 1, 2010. Dr. Bernanke also serves as Chairman of the Federal Open Market Committee, the System's principal monetary policymaking body. He originally took office as Chairman on February 1, 2006, when he also began a 14-year term as a member of the Board. His second term as Chairman ends January 31, 2014, and his term as a Board member ends January 31, 2020. Before his appointment as Chairman, Dr. Bernanke was the "water boy" at a construction site and a busboy at South of the Border, (a roadside attraction in his hometown of Dillon.) Later he became Chairman of the President's Council of Economic Advisers, *(June 2005 to January 2006.)

Dr. Bernanke has already served the Federal Reserve System in several roles. He was a member of the Board of Governors of the Federal Reserve System from 2002 to 2005; a visiting scholar at the Federal Reserve Banks of Philadelphia (1987-89), Boston (1989-90), and New York (1990-91, 1994-96); and a member of the Academic Advisory Panel at the Federal Reserve Bank of New York (1990-2002).

From 1994 to 1996, Dr. Bernanke was the Class of 1926 Professor of Economics and Public Affairs at Princeton University. He was the Howard Harrison and Gabrielle Snyder Beck Professor of Economics and Public Affairs and Chair of the Economics Department at the university from 1996 to 2002. Dr. Bernanke had been a Professor of Economics and Public Affairs at Princeton since 1985. Before arriving at Princeton, Dr. Bernanke was an Associate Professor of Economics (1983-85) and an Assistant Professor of Economics (1979-83) at the Graduate School of Business at Stanford University. His teaching career also included serving as a Visiting Professor of Economics at New York University (1993) and at the Massachusetts Institute of Technology (1989-90).

Dr. Bernanke has published many articles on a wide variety of economic issues, including monetary policy and macroeconomics, and he is the author of several scholarly books and two textbooks. (Apparently he once was a "spelling-b" at age 11 #lulz) He has held a Guggenheim Fellowship and a Sloan Fellowship, and he is a Fellow of the Econometric Society and of the American Academy of Arts and Sciences. Dr. Bernanke served as the Director of the Monetary Economics Program of the National Bureau of Economic Research (NBER) and as a member of the NBER's Business Cycle Dating Committee. In July 2001, he was appointed Editor of the American Economic Review. Dr. Bernanke's work with civic and professional groups includes having served two terms as a member of the Montgomery Township (N.J.) Board of Education.

Dr. Bernanke was born in December 1953 in Augusta, Georgia, and grew up in Dillon, South Carolina. He received a B.A. in economics in 1975 from Harvard University (summa cum laude) and a Ph.D. in economics in 1979 from the Massachusetts Institute of Technology. Dr. Bernanke is married and has two children.

Bush appointed him to be Chairman of the USFR on February 1, 2006; 2nd term was confirmed on January 28, 2010; on September 18 Treasury Secretary Henry Paulson and Ben Bernanke meet with key legislators to propose a \$700 billion emergency bailout through the purchase of toxic assets.

Bernanke, on the financial crisis:

On February 15, 2007, Fed Chairman Bernanke said: "The Federal Reserve takes financial crisis management extremely seriously, and we have made a number of efforts to improve our monitoring of the financial markets to study and assess vulnerabilities, and to strengthen our own crisis management procedures and our business continuity plans."

On February 28, 2008, Fed Chairman Bernanke said: "Among the largest banks, the capital ratios remain good and I don't expect any serious problems . among the large, internationally active banks that make up a very substantial part of our banking system."

On July 16, 2008, Fed Chairman Bernanke said that Fannie Mae and Freddie Mac are adequately capitalized and in no danger of failing. Since then, Fannie Mae and Freddie Mac have received a \$200 billion bailout and have been taken over by the federal government.

The day before we got that blowout January jobs report last week, Federal Reserve Chairman Ben Bernanke delivered his semi-annual testimony on the economy before members of Congress. The QA session that followed opened the forum for Bernanke to get grilled by both Republicans and Democrats. One side blasted his low rate policy, and the other saying he's not doing enough to bolster the economy.

It's not uncommon for the Fed chief to serve as a punching bag, according Vincent Reinhart, Chief U.S. Economist at Morgan Stanley and the former Director of the Division of Monetary Affairs at the Federal Reserve in the attached video. And with 8.3% unemployment they still have room to be accommodative, at least for a while.

For his part, Bernanke did call the recovery frustratingly slow and hit back at Congress (a bit) by highlighting the need for them to get the country's fiscal house in order. Reinhart describes this as simply alerting lawmakers that we are at risk due to our unhinged fiscal policy.

While these sorts of budgetary warnings have been being made forever, Reinhart thinks the U.S. is currently facing a couple of opportunities to mess things up if action isn't taken soon to extend unemployment benefits, the payroll tax cuts, and address the Bush tax cuts which expire in 2013.

Investors have reason to be worried about event risk, he says, something that is bad for market conviction but also could lead to a repeat of the debt ceiling showdown of last August, especially if economic activity isn't that robust and tax receipts disappoint.

External risks, or those from overseas, are another reason Reinhart sees the Fed staying easy on rate hikes as they've promised to do through 2014.

In terms of major risk factors, there is an ongoing banking and sovereign crisis in Europe. Europe is in recession right now. If politicians and other officials don't handle this crisis well then we'll get blow-back to the US.
